same directly to the applicant / appellant / complainant under intimation to the "Information Cell" within the stipulated time period.

Non supply of the required information / views in time shall be the personal responsibility of the concerned P.I.O. and he shall be answerable to the Hon'ble State Information Commission, Incase complaint petitions / second appeal petitions are filed / received, the concerned P.I.O. shall be required to appear before the Commission in person.
