In pursuance of the order dated 16.01.2019 of Hon'ble National Green Tribunal, Principal Bench, New Delhi, the review meetings were held under the Chairmanship of Chief Secretary, Odisha on 14.02.2019 (within one month of the order), 02.03.2019 and 20.03.2019 to monitor the progress of Solid Waste Management in the State.

1. Status of compliance of SWM Rule, 2016, Plastic Waste Management Rules, 2016 and Bio-Medical Waste Management Rules, 2016.

A. Status of Solid Waste Management

- i) The State of Odisha has an urban population of 16.68% as per 2011 census compared to the 31.16% for the country. The urban population is spread across 114 ULBs (consisting of total 2024 wards), which include 5 Municipal Corporations, 48 Municipalities and 61 NACs.
- **ii)** The Government of Odisha have notified Odisha Urban Sanitation Policy, 2017 and Odisha Urban Sanitation Strategy, 2017under rule 11(a) of Solid Waste Management Rules, 2016.
- iii) 104 ULBs have notified SWM Bye-Laws under Rule 15(e) of the Solid Waste Management Rules, 2016. Rest 10 ULBs are in different stages of publishing the Bye-Laws. All the 114 ULBs have prepared the Solid Waste Management action plan.
- **iv)** Total waste generated is 2,686 TPD (0.98 Million Ton Annually), out of which 612 TPD (22.7%) waste is processed.
- v) Waste processing is operational for 612 TPD (Puri Compost Plant of 100 TPD, Berhampur of 1 TPD (decentralised), Rourkela of 0.5 TPD (decentralised), Cuttack: 0.5 TPD (decentralised), Pit Composting in other 96 ULBs in total 509 TPD) and under Construction for 190 TPD (Decentralised Compost Plant at Berhampur of 150 TPD (will be completed by January 2020) & Joda of 5 TPD (will be completed by September 2019)).
- **vi)** For Bhubaneswar and Cuttack agreement has been signed with concessionaire for setting up of 550 TPD centralized Waste to Energy plant. The construction activity could not be started due to large scale public resistance.
- vii) For Rourkela, 110 TPD Waste to Energy centralised plant tender process initiated by RSP Ltd. got into problem. Backup plan Decentralised compost plants shall be set up.
- **viii)** Decentralised compost plants will be set up with a total capacity of 215 TPD in 45 ULBs by 30th April 2020 where land has already been identified.

x) Regulatory Framework for Rural Area

- 1. The State Rural Sanitation Policy and Strategy is being drafted and will come into effect by 15th August 2019.
- 2. An advisory on Waste Management has been sent to all the districts wherein the GPs have been requested to measure the Village Swachhata Index (C) and SLWM Index (S) as per instructions by MoDWS, Gol. The GPs will prepare an Action Plan based on the same which shall be adopted during the Special Gram Sabha on 15th August.
- 3. The draft Bye-Laws on Solid Waste Management in accordance with Solid Waste Management Rules 2016 for adoption by GPs are under preparation. GPs will be requested to adopt and notify the same by 15th August 2019.

xi) Model Villages

- 1. Three ODF GPs (Balianta GP, Balianta Block, Khordha; Gadasantri GP, Banarpal Block, Angul; Kundheigola GP, Reamal Block, Deogarh) have been identified in 3 Revenue Divisions as Model GPs for Solid Waste Management. The action plans for SWM in these GPs is under preparation and will be completed by 30th June 2019. The implementation will be taken up upon completion of the plans.
- 2. Based on the results, similar action plans will be developed for other GPs and activities will be carried out.

3. The expenditure incurred for above activities will be met out of SBM(G) Funds.

xii) Rurban Clusters

- Presently under NRUM, 14 districts, 14 Blocks (1 Block per district) and 61 GPs are covered. An assessment of the Solid Waste Generated in these Rurban Clusters will be made and management plan for the same will be finalized by 15th August 2019.
- 2. The activities will be jointly undertaken by the Odisha Water and Sanitation Mission (OWSM) and Rurban Mission.
- 3. The expenditure incurred for activities maybe met out of SBM(G) Fund and NRUM Fund.

xiii) Sanitation-Based Livelihood Generation

- 10 Producers Group (PGs)/Self-Help Groups (SHGs) under OLM are being identified to take up Sanitation Activities for livelihood generation. The groups and activities will be identified by 30th June 2019 after which they will be imparted training by the OWSM in convergence with OLM.
- 2. The PGs/SHGs will be encouraged to take up activities like:
 - a. Door to door collection of waste, processing and managing the waste-processing facilities
 - b. Production of Eco-Friendly Products
 - c. Production of Sanitary Napkins, Diapers etc.
- The activities will be piloted in Rurban Clusters and Model GPs and will be replicated across the state. The program will be operationalized by 2nd Oct 2019
- The expenditure incurred for above activities maybe met out of SBM(G)
 Fund and NRLM/OLM Fund.

xiv) Rule 23. Review of implementation of provisions under SWM Rules, 2016 by the State Level Advisory Body:

The State Level Advisory Body (SLAB) has been constituted in Notification Number 24239, Dated 26.10.2017 under rule 23 and periodical reviews

conducted in every six months (copy enclosed as **Annexure I**). The last meeting of SLAB was held on 31.10.2018.

xv) Rule 24.Submission of Annual Report:

107 ULBs have submitted the Annual Report.

xvi) Trapping of Drains

A working team has been formed consisting of officers and specialists from Housing & Urban Development Dept. and Water Resources Dept. to develop appropriate modalities and implementation strategy.

xvii) Provision of Funds:

State is committed to provide required funds for taking up various activities under SWM Rules, 2016. For this purpose, funds from Swachh Bharat Mission (Urban), FC grants, District Mineral Foundation (DMF), Odisha Mineral Bearing Areas Development Corporation (OMBADC), Odisha Urban Infrastructure Development Fund (OUIDF) and State Budget will be leveraged.

Duties of State Pollution Control Board

- (a) The State Pollution Control Board shall enforce these rules in their State through local bodies in their respective jurisdiction and review implementation of these rules at least twice a year in close coordination with concerned Directorate of Municipal Administration or Secretary-in-charge of State Urban Development Department;
- (b) monitor environmental standards and adherence to conditions as specified under the Schedule I and Schedule II for waste processing and disposal sites;

- (c) examine the proposal for authorisation and make such inquiries as deemed fit, after the receipt of the application for the same in Form I from the local body or any other agency authorised by the local body
- (d) while examining the proposal for authorisation. the requirement consents under respective enactments and views of other agencies like the State Urban Development Department, the Town and Country Planning Department, District Planning Committee Area Metropolitan or Committee, as may Plannina be applicable, Airport or Airbase Authority, the Ground Water Board, Railways, power distribution companies, highway department and other relevant agencies shall taken into be

Compliance Status

The Board is constantly pursuing the matter with all ULBs (114 nos) as well as H & U.D. Department, Government of Odisha for implementation of the provisions of the rules.

As on date, 29 ULBs are having valid authorisation under the rules.

Periodical inspection of the authorised disposal sites is carried out by the Regional Offices and action is taken in case of any deviation is noticed. In the recent past environmental compensation of Rs.25,000/- was imposed on Bhubaneswar Municipal Corporation for open burning of solid waste of the disposal site at Bhuasuni.

The specified procedure is being followed for consideration of authorisation after the application in complete form is received from the ULBs.

Faecal Sludge and Septage Management (FSSM) in the urban towns of Odisha Policy growth:

The Government of Odisha (GoO) have recognized the significance of adopting a comprehensive approach to FSSM in the urban areas and start the FSSM journey in a systematic manner to provide sanitation infrastructure and services with an objective to have interventions across the value chains with formulation of:

- [1] Odisha Urban Sanitation Policy
- [2] Odisha Urban Sanitation Strategy and
- [3] Odisha Urban Septage Management Guidelines, 2016

Further, Model Faecal Sludge and Septage Management Regulations, 2018 has been formulated by the H&UD Department and circulated amongst ULBs to provide a regulatory framework and an enforcement mechanism for proper onsite sanitation activities including construction of septic tanks/pits, cleaning of septic tanks/pits, deployment of septage transport vehicles or cesspool emptier vehicles, designated disposal sites, septage treatment plants etc.

Infrastructure development:

- The Government of Odisha have established Septage Treatment Plants
 (SeTPs) and Faecal Sludge Treatment Plants (FSTP) to treat the faecal
 waste at Baripada, Berhampur, Bhubaneswar, Puri, Rourkela, Sambalpur
 and Dhenkanal. This caters to nearly 50% urban population of Odisha.
 Appreciating the same, the National Institute of Urban Affairs has
 felicitated six ULBs.
- Three SeTPs are under construction in the towns of Angul, Balasore and Cuttack.
- Recently Government have also taken decision to construct SeTPs in 26 urban towns of Odisha.
- The GoO has made investments to supply cesspool emptier vehicles to
 ensure safe emptying and transportation of the contained faecal waste.
 So far, 203 cesspool emptier have been provided to the ULBs in the state.
 These vehicles are equipped with technological options such as global
 positioning system (GPS) trackers to enable tracking and improvement in
 service delivery. They also come with personal protective equipment

(PPE) to comply with safety norms related to cesspool emptying and transport and to facilitate mechanized emptying as against manual emptying.

 As an interim measure, for containment and treatment of faecal sludge, ULBs have adopted deep row entrenchment (DRE) method. This has reduced the indiscriminate disposal of faecal sludge in 80 urban bodies of Odisha.

Capacity building and training:

Training module on Non Sewered Urban Sanitation was developed for deeper understanding of FSSM amongst stakeholders involved in FSSM. Training of master trainers was conducted for 11 Districts as well as for various project management units (PMUs). This was followed by, capacity building workshops, orientations of the ULB officials, district administration, community-based organizations (CBOs) and cesspool emptier vehicle operators. Training of masons for construction of septic tanks as per CEEPHO guidelines is being planned in coordination with the Labour Department.

Inclusion of basics of FSSM in school curriculum:

To impart knowledge on FSSM in schools, a chapter is proposed to be added in the curriculum of VIII and IX.

B. Status of Plastic Waste Management

- i) Forest & Environment Department has issued specific directions invoking provisions under Section 5 of Environment (Protection) Act, 1986 vide order No.21103 dated 29.09.2018 to ban the use, sale, trade, manufacture, import, store, carry, transport and distribution of certain types of plastic products and thermocol products within six Municipal Corporation/Municipality Limits of Bhubaneswar, Cuttack, Berhampur, Rourkela, Sambalpur and Puri. The order is effective from 2nd October, 2018. A copy of the order is enclosed as **Annexure-II.**
- ii) The progress of enforcement of directions for restriction in use of polythene bags, thermocol and similar plastic products in 6 municipal Corporation Limits are reviewed from time to time. The restriction may be extended to other 48 municipalities of the State in future.
- iii) Direction has been be issued by SPCB, Odisha under section 33 (A) of Water Act, 1974 and section 31 (A) of Air Act, 1981 to notify Similipal Biosphere Reserve as Plastic Free Zone.
- iv) SPCB has issued registration to 7 nos of plastic product manufacturing units, 4 nos of brand owners, and one plastic recycler as on 31st December, 2018.
- v) All Urban Local Bodies (ULBs) have been instructed not to carry out open burning of plastic waste.
- vi) ULBs have been instructed to collect fine for violation of the provisions of the Plastic Waste Management Rules, 2016. They are also requested to include user fees and fine in their By-laws.
- vii) Plastic waste has been included in Schedule of Rates by Works Department and also in Tender Document for road construction.
- viii) RD Department has utilized about 4.6 MT of plastic waste for construction of 9.6 km road in Deogarh and Sambalpur districts under Pradhan Mantri Gram Sadak Yojana.
- ix) Nearby Municipalities are sending plastic wastes to ACC Bargarh Cement Works factory for co-processing as alternate fuel. During 2016-17, 2.44 MT; during 2017-18, 8.84 MT and during 2018-19 (up to February 2019), 21.82 MT of plastic wastes have been utilized.
- x) A large number of IEC materials relating to plastic waste management and special activities on plastic free campaign have been developed and distributed.
- xi) The State Level Advisory Committee has been constituted by the Housing and Urban Development Deptt. vide Notification No.-3558 dated 15.02.2017 under Rule 16 for effective monitoring of implementation of provisions of the Plastic Waste Management Rules, 2016. A copy of the notification is enclosed as **Annexure-III**.

- xii) Further, District level Task Force has been constituted by H & UD Deptt. Vide Notification No-9047 dated 10.04.2018 to plan, supervise, monitor and ensure implementation of said Rules within the territorial jurisdiction of the District concerned. A copy of the notification is enclosed as **Annexure IV**.
- xiii) A three member squad has been constituted by SPCB to identify illegal/unauthorized plastic units and verify manufacturing of substandard carry bags with less than 50 micron thickness.
- xiv) An amount of Rs. 30.74 lakh has been collected as fine by the Municipal Authorities from the violators.

- i) SPCB has published notices in local newspaper to draw attention of the occupiers of Health Care Establishments (HCEs) & operators of Common Biomedical Waste Treatment & Disposal Facilities (CBWTDFs) regarding statutory provisions of the Rules and furnishing necessary compliance.
- ii) All the occupiers of HCEs & operators of CBWTDFs were requested to phase out use of chlorinated plastic bags, containers and gloves through paper notice.
- iii) All the occupiers of HCEs were requested for establishing a Bar-Code System and the operators of CBWTDFs were requested for establishing a Bar-Code System and GPS through paper notice.
- iv) All the existing BMW incinerator operators were requested to comply with the emission standards for treatment and disposal of bio-medical waste prescribed under Schedule-II of the BMWM Rules, 2016 for

- retention time in secondary chamber and Dioxins and Furans through paper notice.
- v) All the occupiers of HCEs were requested through paper notice not to develop onsite treatment facility if a CBWTDF is located at 75 KM distance.
- vi) One time authorization is granted to the non-bedded HCEs after notification of the Biomedical Waste Management Rules, 2016. Paper Notice in this regard is published on 20.08.2017 in Samaj and Dharitri vide Notice No. 10838, dtd. 17.08.2017.
- vii) Authorization Status of Health Care Establishments (HCEs) (Private/ Public Sectors/ Trust/ Central Government)

- viii) Regular training & awareness programme has been conducted.
- ix) Regular inspection is carried out for verification of the provisions of the Rules.
- x) The facility after due verification of necessary capacity to handle biomedical waste in accordance with these Rules, grant/renewal of authorization is decided with due procedure.
- xi) There is one private Common BMW Treatment Facility at Tangiapada, Khurda. The biomedical waste treatment and disposal facilities available at three Government medical colleges and hospitals, and one Government hospital are being utilized by nearby HCEs.
- xii) Board has filed 21 cases against HCEs for violation of the provisions of the Rules.

- State Level Committee has been constituted vide Notification No.2855 dated 08.02.2019 under the Chairmanship of Justice P. K. Mohanty. (Copy enclosed as Annexure- VI.
- All logistics support have been provided for effective functioning of the State Level Committee.
- The first meetings of the State Level Committee was held on 14.02.2019 at Circuit House, Cuttack. Subsequently, second meeting was held on 12.03.2019 and third meeting is scheduled to be held on 02.04.2019.
- Special Task Force in every district has been constituted vide Office Order 5019 date 08.03.2019 of Forest & Environment Department to create awareness about the Solid Waste Management Rules, 2016 by involving educational, religious and Social organisations including local eco-clubs. A copy of the Officer Order is placed as Annexure-VII.

- 3. Status of the Action Plan in compliance vide order dated 20.09.2018 in the News Item published in "The Hindu" authored by Shri Jacob Koshy Titled "More river stretches are now critically polluted: CPCB (Original Application No. 673/2018).
 - In compliance of order of the Hon'ble NGT dated 20.09.2018 River Rejuvenation Committee (RRC) has been constituted by the State Govt. in Forest & Environment Department vide notification No.24426 dt.12.11.2018 comprising Director, Env.-cum-Special Secretary, Forest & Environment Department, Director, Municipal Administration, H&UD Department, Director, Industries, Member Secretary, State Pollution Control Board as Members under the overall supervision and coordination of Additional Chief Secretary, Forest & Environment Department (Annexure VIII).
 - State Govt. in Forest & Environment Department has also constituted Special Environmental Surveillance Task Force in each district vide Notification No. 25340 dt.24.11.2018 of the State to ensure that no illegal mining taken place in river basin of polluted river stretches (Annexure IX).
 - The 1st Meeting of River Rejuvenation Committee was held on 12.12.2018 at 12.30 PM.
 - In compliance of Hon'ble NGT order dated 20.09.2018 and 19.12.2018, action plan for rejuvenation of 01 Polluted river stretch (Priority-1) was prepared based on Hindon Action plan which was approved by RRC. The approved Action Plan for Priority-I Polluted River Stretch Gangua downstream of Bhubaneswar, was sent to CPCB vide State Pollution Control Board's Letter No.15320 dt.24.12.2018.
 - In compliance to the order of Hon'ble NGT, the progress report was submitted to Hon'ble NGT vide letter No.14917 dt.15.12.2018.
 - As per the order dt.19.12.2018 of Hon'ble NGT, Principal Bench, New Delhi, the water quality of the polluted river stretches have been uploaded in the Board's website.
 - Further all the remaining draft action plans duly approved by RRC have been sent to CPCB vide Board's letter No.1089 dt.25.01.2019 for their

consideration.

- Progress Report was also filed before Hon'ble NGT, Principal Bench, New Delhi vide Board's letter No.1096 dt.25.01.2019.
- CPCB has asked for presentation on Action Plan for Priority-I and presentation was made on 12.02.2019 before the Task Team at CPCB, New Delhi by the officials of SPCB and the views of the Task Team were noted.
- The 2nd Meeting of RRC was held on 13.02.2019 under the Chairmanship of Addl. Chief Secy., Forest & Environment Department wherein the views of Task Team were discussed and it was advised to revise the Action Plan by incorporating the suggestions of the Task Team and the same to be sent to CPCB.
- Accordingly, the Action Plan for Priority-I river stretch i.e. Gangua downstream of Bhubaneswar was revised taking into consideration of the views and suggestions of the Task Team as well as decision taken in the 2nd meeting of RRC. The revised Action Plan was sent to CPCB vide Board's letter No.1966 dt.22.02.2019.
- The website of River Rejuvenation Committee (https://www.rrcodisha.org)
 was launched on 13.02.2019 and communicated to CPCB vide Board's
 Letter No.1855 dt.16.02.2019 as a compliance to the order of Hon'ble
 NGT.

- 4. Status of functioning of Committees constituted in News Item Published in "The Times of India" Authored by Shri Vishwa Mohan Titled "NCAP with Multiple timelines to Clear Air in 102 Cities to be released around August 15" dated 08.10.2018.
 - CPCB has identified six nonattainment cities w.r.t. Ambient Air Quality.
 These are Bhubaneswar, Cuttack, Angul, Talcher, Balasore and Rourkela.
 - In compliance of order of the Hon'ble NGT dated 08.10.2018, Air Quality Monitoring Committee (AQMC) has been constituted under Chairmanship of Additional Chief Secretary, Forest & Environment, Govt. of Odisha, vide Notification No 24823 dated 15.11.2018 (Copy Enclosed as **Annexure X**).
 - A District Level Monitoring Committee (DLMC) has been constituted to review the progress & ensure smooth implementation of the action plan for six non-attainment cities vide Office Order No.5621 dated 16.03.2019 (Annexure – XI).
 - Action plans for all the six cities have been prepared and discussed in AQMC and forwarded to the CPCB on 29.12.2018 for approval.
 - i.The three-member Committee constituted by Hon'ble NGT examined the Action Plans and the CPCB accorded its approval on dt 12.02.2019 for implementing the Action Plans for all the cities and made recommendations to carry out Emission Inventory and Source Apportionment Studies for further improvement.
 - ii.In order to implement the Action Plan, SPCB has proposed a stakeholder workshop on 15th/16th of April, 2019.
 - As per the Order of the Hon'ble NGT, a public redressal portal has been developed to receive and address issues relating to air pollution, and public notices have also been brought out in English and Odia dailies for information of general public.
 - A proposal for strengthening the existing air quality monitoring has been submitted before the CPCB on 02.02.2019, as per the direction of Hon'ble NGT.

- 5. Status of the work in compliance of the directions passed in O.A. No. 173 of 2018, Sudarsan Das v. State of West Bengal &Ors. Order dated 04.09.2018.
 - A Committee of Experts has been constituted by Forest & Environment department Vide Notification No.24761 dated 15.11.2018. A copy of Notification is enclosed as (Annexure – XII).
 - The Committee has submitted a report on Impact of sand mining in Subernarekha River in West Bengal and Odisha- Damage assessment and restoration plan and the said report has been submitted to Hon'ble Justice R.K. Merathia, the Oversight Authority.
 - A Committee has been constituted with DLR&S, Odisha, Cuttack, Collector, Balasore and Tahasildar, Jaleswar for joint demarcation in consultation with the officials of Government of West Bengal vide Revenue & DM Department letter No. 40958/R&DM dtd. 3.11.2018.
 - Department of Land and Land reforms, Govt. of West Bengal have been requested for constitution of a team of officers for joint verification/ demarcation/ survey to resolve the Inter-State boundary Dispute in respect of villages under Jaleswar Tahasil of Balasore District of Odisha and instruct the DLR&S, West Bengal and Collector, West Medinipur to conduct such joint demarcation in consultation with their counterpart in the State of Odisha at the earliest in compliance to orders of Hon'ble NGT vide Revenue & DM Department letter No. 44629 dtd.11.12.2018.
 - A joint meeting among the District Level Officials of both the Districts of Paschim Medinipur of West Bengal and Balasore of Odisha was held at 11.00 A.M on 04.01.2019 in the Special Circuit House, Balasore for detailed discussion on directions given in the orders dt. 04.09.2018 of Hon'ble NGT, New Delhi.
 - In compliance to the Order of Hon'ble NGT, a detailed procedure and timeline for joint demarcation of sairat source in river Subarnarekha has been framed and intimated to DLR&S, Odisha, Collector, Balasore, Sub-Collector and Addl. Settlement Officer, B.M Major Settlement, Balasore, Sr. Scientist, ORSAC, Bhubaneswar and Joint Director, Map Publication & Survey, Jobra Cuttack vide Revenue and DM Department letter No. 41583 dtd. 8.11.2018.
 - Collector, Balasore and SP, Balasore have been directed to seize machines and materials on illegal mining and to provide security to the Oversight Authority during his visit to the spot.

- An amount of Rs. 8.00 lakhs has been sanctioned in favour of Collector,
 Balasore to meet the expenses towards remuneration of Oversight
 Authority (OA) and providing logistic support to him.
- Tahasildar, Jaleswar has issued instruction on dtd. 05.10.2018 to the lessees of 03 number of sand sources operating within 5 Kms. of the interstate boundary line not to operate the sources till further order is obtained.
- The lessees of other 11 number of sand sources beyond 5 Kms. radius of the Inter State Boundary line were instructed to follow the guidelines issued in the mining plans and the Environmental Clearance.
- Superintendent of Police, Balasore has been instructed to deploy adequate number of police personnel to seize the sumps, other machineries, tools, vehicles etc. used for carrying out illegal sand mining and to take appropriate action by filing FIR against the persons involved in illegal mining of sand in that area.
- Collector, Balasore has informed that the incidence of illegal sand mining has been regulated to a large extent.
- SEIAA, Bhubaneswar has revoked the Environmental Clearance in respect of Sekhsarai (Kha) sand source vide their letter No. 6566/SEIAA dated 18.03.2019 basing on the e-mail received from R.K Merathia, Hon'ble Oversight Authority as per orders of Hon'ble NGT in O.A. No. 52/2018. Accordingly the operation of the said sand sairat source has been cancelled by Tahasildar, Jaleswar vide his letter no. 938 dated 19.03.2019.
- Tahasildar, Jaleswar and local police have been regularly keeping close watch and conducting raids to prevent any illegal mining/lifting of sand. Tahasildar, Jaleswar has seized 43 number of vehicles and 03 number of Sump Pumps at the time of raids which were involved in illegal lifting of sand during the period from 01.10.2018 to 28.02.2019 and realized penalty amounting to Rs. 6,35,015/- (Rupees six lakh thirty five thousand and fifteen) only.
- The joint demarcation exercise shall be taken up after the election process is over.

- Status of Action Plan with regard to identification of polluted industrial clusters in O.A. No. 1038/2018, News item published in "The Asian Age" Authored by Sanjay Kaw Titled "CPCB to rank industrial units on pollution levels" dated 13.12.2018.
 - The Central Pollution Control Board, in association with IIT Delhi developed a Comprehensive Environmental Pollution Index (CEPI) in a Source-Pathway Receptor modeling framework during 2009 for evaluation of Industrial Clusters. In Odisha, three industrial clusters; Angul-Talcher (CEPI-82.09), Ib-valley (CEPI-74.00) and Jharsuguda (CEPI-73.34) are identified as critically polluted area. Paradeep Industrial Clusters with a CEPI score of 69.35 was declared as severely polluted area.
 - SPCB has prepared Implementation Status and Action Plan for Critically Polluted Areas of Odisha (Angul-Talcher) (Ib Valley-Jharsuguda) for the period 2010-2015 and Phase-II action plan to be implemented during 2015-2020, and has forwarded it to CPCB on 30-03-2016. The reports have been uploaded at CPCB and SPCB website for public view.
 - The CPAs were monitored by CPCB periodically engaging NABL accredited Laboratory and CEPI score is being evaluated by CPCB. The CEPI score evaluated during 2009 and 2013 is given below;

- Based on directions of CPCB, for monitoring of Action Plans in CPA, State Level Committee and District Level Committee has been set up by Forest and environment Department, Govt. of Odisha, vide order no 13945 dtd. 30-07-2011 for Angul- Talcher area. Similarly, District Level Committee has been set up for Ib Vally and Jharsuguda Area on dt. 19-10-2016 for monitoring of Action Plan.
- In the meantime, CPCB has revised the framework of CEPI and SPCB has received the revised framework for evaluation of CEPI index in critically polluted areas (CPAs) and has forwarded its comments to CPCB for consideration.

- CPCB Delhi has undertaken a project on "Monitoring, sampling and analysis for ambient air quality, surface water quality and ground water quality in around 100 Polluted Industrial Areas (PIAs)-during 2017-18 by engaging M/s Fare Lab, Gurgaon. In this project, CPCB has included 5 Polluted Industrial Areas of Odisha namely; Angul-Talcher, Ib Valley, Jharsuguda, Paradeep and Jajpur (Kalinganagar). SPCB has assisted the third party engaged by CPCB, during environmental monitoring.
- CPCB has directed SPCB to furnish information on each of the 5 PIAs separately in prescribed format. The Odisha SPCB has submitted the information on pollution source, industrial status and health statistics in 5 Polluted Industrial Areas (PIAs), in Odisha for CEPI calculations to CPCB vide letter 5247 dtd. 28-04-2018, and submitted all other information vide its letter dtd. 03-10-2018.
- After receipt of final CEPI scores of 5 PIAs in Odisha, further course of action will be initiated.

- 7. Total amount collected from erring industries on the basis of 'Polluter Pays' principle, 'Precautionary principle' and details of utilization of funds collected.
 - A sum of **Rs.4,83,60,000/-** has been collected as penalty from Hotels and Brick Kilns as per the orders of Hon'ble NGT from 2016-17 up to 31st January. 2019. Out of the total amount collected **Rs.59,67,500/-** has been transferred to CPCB as per the order of Hon'ble NGT.
 - Hence, a balance of **Rs.4,23,92,500/- is** available with the SPCB at present.
 - As per the order of the Hon'ble NGT, the expenditure for the State Level Committee on solid Waste Management will be met from this account.

8. In the matter of Paryavaran Suraksha Samiti OA No 593/2018

- The compliance of status reports of ETPs & STPs in pursuance to the order dtd.03.08.2018 of Hon'ble NGT in the matter of Paryavaran Suraksha Samiti and Anr. v/s Union of India &Ors. (OA No.593 of 2017), (WP(C)-375 of 2012) is being compiled in CPCB prescribed format and submitted through CPCB web portal by 10th of every month since October, 2018.
- SPCB has submitted the compiled status report to CPCB up to February 2019 vide letter No.2447 dated 08.03.2019.

- 9. Status of the identification and development of Model Cities and Towns in the State in the first phase which can be replicated later for other cities and towns of the State.
 - Jajpur Municipality & Chhatrapur NAC have been identified as the model towns.
 - Four cities namely, Jajpur, Paradip, Karanjia & Tarabha have been awarded by the MoHUA for their outstanding performance during Swachh Survekshan 2019.

The 29th September 2018

No. 21103—ENV-I-57/2018-F&E.—Whereas, plastics are non-biodegradable and cause threat to the ecological system as they reduce the fertility of soil and thereby hamper the growth of plants, choke drains and sewer resulting in overflowing gutters and if swallowed by cattle, they may cause death by obstructing their intestine;

And whereas, the colour pigments contaminate food products wrapped in them and cause health hazards and some of it are even carcinogenic;

And whereas, plastic products take hundreds of years for degradation, as they are not biodegradable like paper bags, they also block the rainwater infiltrating into the soil hindering recharge of ground water;

And whereas, the plastic bags when discarded can get filled with rainwater offering ideal breeding ground for vector borne diseases like malaria and burning of plastics also releases most carcinogenic and toxic substances like dioxins, furans and hydrogen cyanide, which pollute air as well as cause severe and chronic health problems:

And whereas, Government of India in the Ministry of Environment, Forest and Climate Change have made the Plastic Waste Management Rules, 2016 under the Environment (Protection) Act, 1986 (29 of 1986) vide Notification No G.S.R. 320(E), dated the 18th March, 2016 restricting the use of certain plastic carry bags and containers and its management;

And whereas, in the past, the State Pollution Control Board and the State Environment Department also took certain steps to restrict the indiscriminate use and littering of polythene carry bags;

And whereas, it is felt necessary that certain stringent steps are needed not only in regard to regulating the use of polythene bags but also restricting the use of thermocol and similar plastic products;

certain types of plastic products in the territorial jurisdiction of 5 Municipalities and Municipal Corporations like; Bhubaneswar, Cuttack, Berhampur, Rourkela and Sambalpur and in famous place of pilgrimage and tourist destination at Puri with effect from the 2nd October, 2018;

And whereas, the draft of certain directions which the State Government proposed to issue in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 (29 of 1986), readwith the notification of the Government of India in the Ministry of Environment and Forests (Department of Environment, Forests and Wild Life) No. SO-152 (E), dated the 10th February, 1988 and rule 4 of the Environment (Protection) Rules, 1986, was published in the extraordinary issue No. 1674 of the *Odisha Gazette*, dated the 5th September, 2018 under the Order of the Government of Odisha in the Forest & Environment Department No 19374-F&E., dated the 4th September, 2018 inviting objections and suggestions from all persons likely to be affected thereby, till the expiry of a period of fifteen days from the date of publication of the said Order in the *Odisha Gazette*;

And whereas, copies of the said Gazette were made available to the public on the 5th September, 2018;

And whereas, the objections and suggestions received during the period so specified above from the public in respect of the said draft Order have been duly considered by the State Government;

NOW, therefore, in exercise of the powers conferred by Section 5 of the Environment (Protection) Act, 1986 (29 of 1986), read with the notification of the Government of India in the Ministry of Environment and Forests (Department of Environment, Forests and Wild Life) No. SO-152 (E), dated the 10th February, 1988 and rule 4 of the Environment (Protection) Rules, 1986, and in supersession of the Order of the Government of Odisha in the Forest & Environment Department No 1321-F&E., dated the 20th January, 2004, the State Government do hereby issue the following directions, namely:—

- 1. (a) No person, by himself or through another, shall knowingly or otherwise, sell, trade, manufacture, import, store, carry, transport, use or distribute the following within the municipal limits or as the case may be within the Municipal Corporation Limits of Bhubaneswar, Cuttack, Berhampur, Rourkela, Sambalpur and Puri, namely:—
 - (i) Polythene carry bags of any shape, thickness and size (excluding compostable);
 - (ii) Bottled drinking water Polyethylene Terephthalate (PET/PETE) bottles of less than 200ml capacity;
 - (iii) Single use disposable cutleries made up of thermocol (polystyrene), polyurethane and the like; or plastic such as dish, spoon, cup, plate, glass, fork, bowl, pouch to store liquid and container etc. of any size and shape excepting for packing and selling of milk and other ancillary milk products; and

- (iv) Thermocol decorative materials (flowers and the like);
- Note: Compostable plastics shall conform to the Indian Standard: IS 17088: 2008. The manufacturers or seller of compostable plastic carry bags shall obtain a certificate from the Central Pollution Control Board before marketing or selling.
- (b) Vendors shall notbe allowed to use polythene sheets of less than 50 micron thickness for storing, transporting, dispensing or packaging of any article or commodity or food items, consumables, packaging of milk and milk products and edible oil in sealed manner. This excludes any plastic for carrying and transporting garbage and containers like cup for milk products including curd and icecream etc., polythene packaging materials used in plant nurseries, horticulture, agriculture and healthcare sector like medicines, blood transportation bags, syringe, sample or specimen bags, resealable bags, medical instruments and accessories etc. and packing materials used for wrapping of any item at manufacturing stage;

Noтe: The expression 'vendor' shall mean any person who sells articles or commodities specified under this Order.

- (c) No person shall knowingly or otherwise, litter any public place with any plastic item allowed under this Order.
- 2. The authorities or owners of places of religious worship or institutions, hotels and restaurants, café, mobile food counters or vans, caterers and other such places like marriage or party halls, offices or institutions and the outdoor event managers located at the places mentioned in sub-Para. (a) of Para. 1 shall be responsible for ensuring strict compliance of the aforesaid directions and they shall provide space for collection of plastic waste within their campus and returning the same to the concerned manufacturer or retailers or supplier.
- 3. Manufacturers or Producers of Polyethylene Terephthalate (PET/PETE) bottles for bottled drinking water and soft drinks shall take back the Polyethylene Terephthalate (PET/PETE) bottles and plastic waste respectively through the same retail sales network under mutually agreed terms and conditions based on Extended Producer's Responsibility.
- 4. The Municipal Commissioners or the Executive Officers of Urban Local Bodies and other concerned officers or agencies as nominated, shall make wide publicity of all provisions of this Order through Press and electronic media.
- 5. The Municipal Commissioner or the Executive Officer shall take adequate steps to implement the restrictions specified under this Order and shall make suitable arrangements for collection and disposal or recycling of any type of plastics item within their jurisdiction.

6. District Collector, Subdivisional Magistrate, Member-Secretary of State Pollution Control Board, who are empowered to take cognizance of offence under the Environment (Protection) Act, 1986 shall enforce the provisions of this Order in their respective jurisdiction.

District Collector shall involve Additional District Magistrate, Superintendent of Police, Divisional Forest Officer, Tahasildar, Regional Officer of State Pollution Control Board, Officers of Municipal Corporation/Municipality and any other Officer nominated by him/her, for enforcing the Order.

- 7. The Cinema Hall owners or proprietors shall exhibit slides in their halls regarding the restriction of plastic use in the State for a period of one year from the date of issue of this Order.
- 8. The State Pollution Control Board shall ensure closure of the industries producing plastic products which are not confirming to the stipulations of this Order within the 6 (six) above Municipal Corporations/Municipalities.
- 9. Centre for Environmental Studies, Odisha shall make necessary public awareness campaign regarding consequences of indiscriminate use and littering of plastics and restrictions imposed under this Order through Non-Government Organizations and Eco clubs.

Noτε: Any person including the vendor possessing any materials, which are prohibited under this Order, shall dispose of those articles within 1(one) month from the date of publication of the Order.




