In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village—**Pipalpadar** under Laxmipur Tahasil in the District of Koraput mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation purpose thereon against approved diversion of 434.935 ha of forest land (428.075ha. of forest land within Kodingamali Bauxite Mining lease area including 18.098 ha of forest land in safety zone and 6.860 ha of forest land outside the ML area for construction of approach road to the mining lease) for mining of bauxite in Kodingamali Bauxite Mines located in Koraput & Rayagada districts of Odisha by Odisha Mining Corporation Ltd. vide letter F.
