ORDER

Dated, Bhubaneswar the 2nd December, 2009

No. 1F(Con)-75/09/20255/F&E. Whereas on the basis of allegation of acquisition and possession of assets disproportionate to the known source of income by Sri Bhimsen Moharana, OFS-I, D.F.O. Deogarh Forest Division, District- Deogarh and on the strength of search warrants issued by the Court of CJM, Sambalpur, the residential Government Quarters of Sri Moharana, OFS-I situated at Deogarh Town (2) his Office room situated at Deogarh Town (3) Three storied building situated on Plot No. IC/19 at Bidanasi Project Area, CDA, Cuttack (4) his ancestral house at Village Sabalasinghpur, District- Kendrapara (5) residential house of Sri Krupasindhu Khamani, Forest Extension Supervisor, Deogarh situated at Sakhipara, Sambalpur & (6) his father-in-law's house situated at Mahipal Bazar, Kendrapara, were searched by the G.A.(Vigilance) Department simultaneously on 19.11.2009.

And whereas during search the total immovable & movable assets possessed by Sri Bhimsen Moharana, OFS-I, D.F.O. in his name and in the name of his family members amounting to Rs. 68,33,057/- were detected which includes hard cash amounting to Rs. 2,94,095/-.

Now, therefore, the Governor of Orissa in exercise of the powers conferred by clause (b) of sub-rule 1 of Rule 12 of the Orissa Civil Services (CCA) Rules, 1962, hereby places the said Sri Bhimsen Moharana, Divisional Forest Officer, Deogarh under suspension with immediate effect with his headquarters fixed at O/O Pr.C.C.F., Orissa, Bhubaneswar
