In view of provision of Section 10(1) of the Compensatory Afforestation Fund Act, 2016, the "Compensatory Afforestation Fund Management and Planning Authority, Odisha" (in short State Authority), has been created by the State Government vide Notification No. 21066/F&E dt. 29.9.2018. The Governing Body, Steering Committee and Executive Committee of the State Authority have also been constituted vide the notification referred to above as per Section 10(5), Section 11(2) and Section 11(3) of the Compensatory Afforestation Fund Act, 2016 respectively.

Following constitution of Steering Committee and Executive Committee of State Authority, the State Government have been pleased to appoint Sri A.B. Otta, Director & Special Secretary, SC&ST Research and Training Institute, Bhubaneswar (an expert on tribal matters) as a Member of the Steering Committee and Executive Committee of State Authority as per provision of Section 11(2)(viii) and Section 11(3)(x) of Compensatory Afforestation Fund Act, 2016.
