NOTIFICATION

No. 10F(Div)-4/2010 *10480* / F&E dated- *5-6-10*.

In exercise of the powers conferred under Section 33 of the Orissa Forest Act - 72 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in Village **Sadhubahal** under Bonai Tahsil of District Sundargarh mutated and transferred for compensatory afforestation purpose against the proposed diversion of forest land in village Tantra and Tensa of M/s Korp. Resources(P) Ltd. vide Government of India, Ministry of Environment and Forests in-principle approval orders in their letter No.8-108/2008-FC dt. 20.2.2009 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 15.783ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**Sadhubahal Protected Forest**".
