In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in Village **Tentulikhunti** PS- Kanjipani under Tahsil Telkoi of District of Keonjhar mutated and transferred for compensatory afforestation purposes against the approved diversion of forest land over 287.0685ha. for Thakurani iron ore project of M/s Sarda Mines Pvt. Ltd. vide Government of India, Ministry of Environment and Forests orders in their letter No.8-55 /2000-FC dt. 21.6.2001 under section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 287.0685ha.. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**Tentulikhunti Protected Forest**".
