
NOTIFICATION

The Special Purpose Vehicle constituted by the State Government pursuant to orders dt. 7.5.2010 of Hon'ble Supreme Court in IA No. 2746-48 of 2009 arising out W.P.(C) No. 202/1995, has since been incorporated as a Company namely ODISHA MINERAL BEARING AREAS DEVELOPMENT CORPORATION(OMBADC) under Sub-section (2) of Section 7 of the Companies Act, 2013 and Rule 8 of the Companies(Incorporation) Rules, 2014 w.e.f 2.12.2014 bearing CIN No. U75100OR2014NPL018478. The State Government have also constituted the Board of Directors of OMBADC under the chairmanship of the Chief Secretary, Odisha vide Notifications of F&E Department bearing No. 2622/F&E dt. 11.2.2015, No. 2981/F&E dt. 20.2.2015, No. 16998/F&E dt. 16.8.2017 and No. 27051/F&E dt. 30.12.2017 nominating official and non-official Members to the Board of Directors.

In order to enable the Planning & Convergence Department to oversee the programmes being implemented out of the funds of OMBADC in mineral bearing districts of the State and with a view for effective convergence of the activities of OMBADC with activities being taken up at present with other extra budgetary resources such as District Mineral Foundations etc., the State Government have further been pleased to bring the OMBADC under the administrative control of Planning & Convergence Department with immediate effect.
