Dated, Bhubaneswar, the 8/2/10

No-10-F(Div)-2/10 2849 F&E, In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in Village **Fikudchundi** in Panposh Tahsil of the District of Sundargarh mutated and transferred for compensatory afforestation purpose against the in-principle diversion of forest land for expansion of Existing Integrated Steel Plant by M/s Adhunik Metaliks Pvt. Ltd. in Village. Chadrihariharpur vide Government of India, Ministry of Environment and Forests orders in their letter No.5ORC-057/2007 FCE dt. 30.11.2007 under Section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 24.34ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**Fikudchundi Protected Forest**".
