In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Kerapai** under Thuamul Rampur Tahasil in the District of Kalahandi mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 345.189 ha. of forest land including 6.919 ha in safety zone within the total mining lease area over 366.311 ha of Khandbandh Iron Ore Mines of M/s OMC Ltd. in Keonjhar district, Odisha vide in-principle approval order No.8-46/2018-FC dtd.31.01.2019 of Government of India, Ministry of Environment, Forests & Climate Change (FC Division) under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 19.651 ha (48.56 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "**Kerapai-B Protected Forest**".
