In exercise of the powers conferred under Section-33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-**Brahmasadhu Bahal** under Deogarh Tahasil in the District of Deogarh mutated and transferred in favour of F&E Department for raising Compensatory Afforestation thereon against the approved diversion of forest land for construction of Rengali Irrigation Project vide Order No.8-53/96-FC (Pt) dtd.14.05.2003 of Government of India, Ministry of Environment and Forests under Section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 37.13ha (91.76 Ac.) shall be Protected Forests with effect from the date of issue of the Notification and shall be known as **Brahmasadhu Bahal Protected Forest**.
