In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in Village **San-sibanathpur** under Bonai tehsil of District Sundargarh mutated and transferred for compensatory afforestation purpose against the proposed diversion of forest land in village Kusumdihi in favour of M/s Bonai Industrial Co. vide Government of India, Ministry of Environment and Forests orders in their letter 8(21)12/2000-FCE dt. 25.3.2008(Stage-I) under section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 1.335ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**San-sibanathpur Protected Forest**".
