In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- Jamchhapar under Sohela Tahasil in the District of Baragarh mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 7.054 ha of forest land for construction of Ranjore Medium Irrigation Project near village Sarandapali in Sohela & Bargarh Tahasil of Baragarh District, Odisha vide in-principle approval order No.5-ORC308/2017-BHU dtd.01.12.2017 of Government of India, Ministry of Environment, Forests & Climate Change, Eastern Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 7.054 ha (17.430 acres), shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "Jamchhapar 'B' Protected Forest".
