In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village—**Ghodadega** under Kusumi Tahasil in the District of Mayurbhanj mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising Compensatory Afforestation thereon against the proposed diversion of 7.819 ha of forest land for widening and strengthening of the existing road to 2 lane with 1.5 Mtr. wide paved shoulder on either side from 35/700 Km to 71/120 Km of NH-220 of Rairangpur to Jashipur Section coming within the jurisdiction of Rairangpur and Karanjia Forest Division under Mayurbhanj District, Odisha by the Executive Engineer, NH Baripada Division vide in-principle approval Order No.5-ORC358/2018-BHU, dt.18.07.2018 of Government of India, MoEF & CC, IRO, Bhubaneswar under Section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 19.320 Ac. or 7.819 ha shall be 'Protected Forest' with effect from the date of issue of the Notification and shall be known as "**Ghodadega Protected Forest**".
