In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-Badasireipur Dorabada under Banpur Tahasil in the District of Khordha mutated and transferred in favour of Forest and Environment Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 10.58 ha of revenue forest land of Sijua village under Bhubaneswar Tahasil of Khordha District under City Forest Division, Bhubaneswar for construction of Centres of Excellence namely Cardio-thorasic & Vascular Surgery (CTVS), Oncology, Neuroscience, Nephrology by AIIMS vide in-principle approval order No.5-ORC439/2020-BHU dtd.07.01.2021 of Government of India, Ministry of Environment, Forests & Climate Change, Integrated Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 10.58 ha (26.150 acres), shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Badasireipur Dorabada Protected Forest**".
