In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Kerapai** under Thuamul Rampur Tahasil in the District of Kalahandi mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed permission for use of 3.606 ha of forest land within total mining lease area of 264.466 ha in Kathapal Chromite Mining Lease located in Kankadahad Tahasil and Kamakshyanagar (East) forest range of Dhenkanal forest division in Dhenkanal district for undertaking exploratory drilling of 40 no. of boreholes of 4" dia (40 boreholes @0.02ha each totaling .08 ha and 2.806 ha for construction of road) by M/s Odisha Mining Corporation Ltd. for prospecting of minerals vide Final approval order No.8-45/2016-FC dtd.19.12.2017 of Government of India, Ministry of Environment, Forests & Climate Change (FC Division) under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 3.606 ha (8.91 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "**Kerapai Protected Forest**".
