In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-Patuakudar under Jhumpura Tahasil in the District of Keonjhar mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 22.368 ha of forest land for construction of 33KV Power Transmission Line from Jaroli Sub-Station to PMPL Plant at Basantpur under Keonjhar Forest Division passing through Barbil & Jhumpura Tahasil in Keonjhar District by M/s Pro-Minerals Pvt. Ltd. vide inprinciple approval order No.5-ORC450/2021-BHU dtd.08.06.2021 of Government of India, Ministry of Environment, Forests & Climate Change, Integrated Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 8.0555 ha (19.905 acres), shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "Patuakudar Protected Forest".
