NOTIFICATION

No. 10F(Div)-8/2010/ *19208* /F&E dated- *24.8.10*

In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Village **Kasia under** Barbil Tahsil of the district of Keonjhar mutated and transferred for compensatory afforestation purposes against the proposed diversion of forest land for Silijoda-Kalimati Iron and Manganese Mines of M/s Mangilal Rungta vide in-principle approval order No. 8-104/96-FC(Pt) dt. 22.10.2009 of Government of India, Ministry of Environment and Forests under section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 105.396ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**Kasia**" Protected Forest".


