NOTIFICATION

Dated, Bhubaneswar, the 25/01/10

No. KL-(B)-4/2008 1899 /F&E, In pursuance of Sub-Section(I) of Section-4 of Orissa Kendu Leaves (Control of Trade) Act, 1961 (Orissa Act-28 of 1961), the State Government after consultation with the Kendu Leave Advisory Committee do hereby fix the following price at which Kendu leaves shall be purchased by them or by any of their authorized officers in all units of the State during the KL Crop year 2010.

- (a) 20 green leaves inclusive of 2 cover leaves (One Kerry) fit for Bidi Making will be purchased at the rate of 34 paisa from the pluckers in the process KL production area.
- (b) 40 green leaves inclusive of 2 Cover Leaves (One Kerry) fit for Bidi Making will be purchased at the rate of 68 Paisa from the pluckers in Phal KL Production area.
- (c) The Growers Leaves will be purchased at the rate of Rs. 1900 /- only per quintal inclusive of drying and storage charges, subject to following stipulations :-
 - (i) The processing of growers Leaves have to be carried out by the KL Organization at its own cost and the payment to individual growers will be made after binding of the leaves delivered by each grower.
 - (ii) The purchase of grower's leaves shall be within the targeted KL production.
 - (iii) The procurement of Grower's Leaves shall be subject to detailed survey and registration of KL growers.


