No.10F (Cons) 94/2018 1777 /F&E, Date 25.1.19

In exercise of the powers conferred under Section-33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-**Arakhataila** under Daspalla Tahasil in the District of Nayagarh mutated and transferred in favour of F&E Department for raising Compensatory Afforestation thereon against the proposed diversion of 1524.17ha of forest land for construction of Brutanga Major Irrigation Project vide in principle approval Order No.8-23/2010-FC dtd.31.08.2010/dtd.09.09.2010 of Government of India, Ministry of Environment and Forests & Climate Change, New Delhi under Section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 95.75ha (236.60 Ac.) shall be Protected Forests with effect from the date of issue of the Notification and shall be known as **Arakhataila Protected Forest**.
