NOTIFICATION

No.10F(Cons)-41/07(Pt-III) - 9444 IF&E. Date: 24-5-10

In pursuance of the order of Hon'ble Supreme Court of India dated 10.7.2009 in IA No.2143 in W.P. (C) No.202/1995 approving/accepting guidelines and composition of the State Compensatory Afforestation Fund Management and Planning Authority (State CAMPA) suggested by the Govt. of India, MoEF dated. 2.7.2009, the State Government have constituted an authority known as "State Compensatory Afforestation Fund Management and Planning Authority, Orissa (State CAMPA, Orissa) " vide their notification dt. 13995/F&E dt. 14.8.2009 indicating details of aims and objectives of the State CAMPA, the composition of the Governing Body, Steering Committee and Executive Committee of the State CAMPA with their functions.

As per Para 14 and 15 of the guidelines dated 2.7.2009 of Government of India, Ministry of Environment & Forests on State CAMPA, the State Government vide their Notification referred to above, have earlier constituted the three Committees namely, Governing Body, Steering Committee and Executive Committee of the State CAMPA under the chairmanship of the Hon'ble Chief Minister, Chief Secretary and Pr. Chief Conservator of Forests, Orissa respectively for smooth management of the affairs of the State CAMPA, Orissa. The composition of the Steering Committee and Executive Committee of the State-CAMPA was indicated at para 5.2 and 5.3 of the above mentioned notification with Chief Conservator of Forests (Plan, Programme and Afforestation), and Chief Conservator of Forests (Forest Diversion) and Nodal Officer, in the Office of the PCCF, Orissa functioning as Member Secretary of the said two committees respectively. However, keeping in view that one post of Chief Conservator of Forests (CAMPA) has been created vide G.A. Department letter No.AIS-III-8/2007- 2555/AIS-I dt. 27.1.2007 and appointment of senior forest officers being made against the said post vide F&E Department Notification from time to time, the latest being vide No. 7072/F&E dt. 17.4.2010, the Government have been pleased to decide that the Chief Conservator of Forests (CAMPA) in the office of Pr. Chief Conservator of Forests, Orissa shall function as Member Secretary of the Steering Committee and Executive

Committee of the State-CAMPA in order to make him accountable for implementation, monitoring and evaluation of the CAMPA Action Plan in the State. The Chief Conservator of Forests (Plan, Programme and Afforestation) and Chief Conservator of Forests (Forest Diversion) and Nodal Officer in the Office of the PCCF, Orissa shall continue as Members of the Steering Committee and Executive Committee. Similarly, as communicated by the Govt. of India, MoEF vide their letter F.No. 14-3/2009-CAMPA dt. 26.11.2009 and No. 11-34/2010-FC dt. 5.4.2010, the Chief Conservator of Forests(Central), Eastern Regional Office, MoEF, Govt. of India, Bhubaneswar shall be the representative of the Ministry of Environment and Forests, Govt. of India in the Steering Committee of the State-CAMPA, Orissa. Accordingly, the composition of the Steering Committee and Executive Committee of the State-CAMPA, Orissa are hereby modified as indicated below.

5.2 Steering Committee of State CAMPA

The Steering Committee of State CAMPA shall consist of the following :
