In exercise of the powers conferred by Section 33 of the Orissa Forest Act 1972 (Orissa) Act 14 of 1972, the State Government do hereby declare that the land situated in Village **Barunia** under Darpan Tahsil of the District of Jajpur mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for Chromite Mining by M/s Balasore Alloys Ltd. vide Government of India, Ministry of Environment and Forests order in their letter No.5-ORC 017/2005-FCE dated the 10.10.2006(Stage-I) under section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 34.25ha.(84.60Acs) shall be Protected Forests with effect from the date of issue of Notification and shall be Known as "**Barunia Protected Forest**".


