In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in Village **Rengali** under Rengali tehsil of the District of Sambalpur mutated and transferred for compensatory afforestation purposes against the proposed diversion of forest land for establishment of Aluminium Smelter & Captive Power Plant project by Aditya Aluminium (A Division of M/s Hindalco Industries Ltd) vide Government of India , Ministry of Environment and Forests orders in their letter No.8-27/ 2009-FC dt. 10th November 2009 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the total area of which is 39.4205ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be Known as "**Rengali Protected Forest**".
