In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village - **Uparjhabi** under Thuamul Rampur Tahasil in the District of Kalahandi mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising Compensatory Afforestation thereon against proposed diversion of forest land involved in the mining lease over 1243.27 ha for mining of Iron and Manganese Ore in Dubna-Sakradihi Mines in Keonjhar District, Odisha of Odisha Mining Corporation Ltd. vide letter F. No.8-26/2019FC dt.06.05.2021 of Government of India, Ministry of Environment, Forests & Climate Change (FC Division) under Section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 266.942 ha (659.63 acres), shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Uparjhabi Protected Forest**".


