In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village–**Tulasadeipur** under Bhubaneswar Tahasil in the District of Khordha mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising Compensatory Afforestation thereon against the proposed diversion of 10.183 ha of forest land under Chandaka Wildlife Division for construction of 200 feet wide Master Plan Road over a length of 1.790 Km from Rail Vihar-Hatiasuni-Ekamrakanan Park within Left Side Road Network (LSRN) (Modified CDP-02/2017) in Bhubaneswar City coming under Bhubaneswar Tahasil of Khordha District, Odisha vide in-principle approval order of Government of India, Ministry of Environment, Forests & Climate Change, ERO, Bhubaneswar communicated in Letter No.5-ORC373/2019-BHU, dt.29.03.2019 under Section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 10.3725 ha (25.631 Ac.), shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Tulasadeipur Protected Forest**".


