No. FE-FE2-FE-0069-2018 <u>48669</u> /FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Deputy Rangers to the rank of Forest Rangers was held on 29.12.2021.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Madhav Chandra Naik, Deputy Ranger was kept in "Sealed Cover" due to the pendency of Disciplinary proceeding against him.

And whereas, the Departmental Proceeding initiated against Sri Naik vide Memorandum No. 4375 dated 01.11.2021 of RCCF, Angul Circle has been finalized vide the OO No. 179 dated 20.06.2022 of RCCF, Angul Circle with the following punishments:

- · He is severely warned for future.
- · One annual increment is stopped without cumulative effect.

And whereas, the Sealed Cover containing the findings of the Departmental Promotion Committee dated 29.12.2021 in respect of Sri Naik, Deputy Ranger has been opened on 11.07.2022 and he is found suitable for promotion to the rank of Forest Ranger, OFS, Group-B as per Para-3 of GA & PG Department OM No. 7844 dated 04.03.2020.

And whereas, inter-se seniority of Sri Madhab Chandra Naik will be above Sri Dibya Shankar Behera (Sl No. 50) and below Sri Sandeep Kumar Panigrahi (Sl No.45) in the seniority list.

Hence, after careful consideration the Government have been pleased to promote Sri Madhav Chandra Naik, Deputy Ranger notionally to the rank of Forest Ranger, OFS, Group-B on ad-hoc basis for a period of one year or till receipt of the concurrence of OPSC or till his retirement, whichever is earlier in the Scale of Pay in Level 10 of Pay Matrix under ORSP Rules 2017 with usual D.A and other allowances as admissible from time to time w.e.f. the actual date of joining in the promotional post of Forest Ranger.

Sri Naik will not be eligible for any arrear financial benefits for the period for which he has not actually worked in the higher grade post.

On promotion to the rank of Forest Ranger, Sri Madhav Chandra Naik is posted to Jarpada Range under Angul Forest Division with immediate effect.
