No.FE-DIV-FLD-0084-2022-(10F(Cons)-44/2022)- 20194 /FE&CC, In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-Salangabud under Sundargarh Tahasil in the District of Sundargarh mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion of 39.110 ha of Forest Land for expansion of Sambalpur-Sundargarh-Rourkela Road (SH-10) from existing 2-laning to 4-laning (4/900 Km to 167/400 Km) by the Executive Engineer, Sundargarh (R&B) Division, Sundargarh, Odisha, vide in-principle approval of Government of India, MoEF&CC, ERO, Bhubaneswar communicated in Letter No.5-ORC271/2015-BHU, dt.11.02.2016 under section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 26.631 ha (65.807 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "Salangabud Protected Forest".
