No.FE-DIV-FLD-0085-2021-(10F(Cons)-44/2021)-20899 /FE&CC, In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Dangajore** under Lanjigarh Tahasil in the District of Kalahandi mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion of 15.265 ha of forest land for expansion of existing Red Mud Pond at village Rengopalli under Lanjigarh Tahasil in Kalahandi District of Odisha in favour of M/s IDCO, Bhubaneswar under Kalahandi South Forest Division, vide "in-principle" approval of Government of India, MoEF&CC, IRO, Bhubaneswar communicated in Letter No.5-ORC469/2021-BHU, dt.17.11.2021 under section-2 of Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 16.49 ha (40.75 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Dangajore Protected Forest**".


