## Proceedings of the "Consultant Evaluation Committee" for evaluation financial bid for "Selection of an agency for outsourcing of services under POSHAN Abhiyaan in Odisha"

As per the schedule, the Consultant Evaluation Committee (CEC) met on 27.10.2022 at 11.00 A.M under the chairmanship of FAcum-Special Secretary to Government, WCD Deptt. in the Conference Hall of this Deptt. for final evaluation of bid for Selection of an agency for outsourcing of services under POSHAN Abhiyaan in Odisha. The members of the committee are enclosed at Annexure A.

In response to the Request for Proposal (RFP) dated 20.08.2022, eleven (11) no. of bids were received out of which 4 bids were found to be non-responsive. The Committee evaluated technical bid of responsive bidders and the proceeding of Technical Evaluation has been uploaded in the State Procurement portal. Therefore, the Committee opened the financial bids of 7 responsive bidders for scrutiny and evaluation on 27.10.2022.

The details of the bids and their quoted rates are enclosed at **Annexure-B.** The CEC after deliberation and unanimity took the decisions as follows.

 The CEC found that The bidder "Rajdeep Enterprises" was ineligible for evaluation of Financial Bid on the following ground-

As per Section- 2, Clause 5(II) of RFP, "Any deviation from the prescribed procedures / information / formats / conditions shall result in out-right rejection of the proposal". But,

- the bidder has not uploaded Fin-2 which was a mandatory requirement
- ii. No amount has been mentioned in the covering letter (Fin-1).

iii. The service charge quoted by the bidder is INR 8.99/-only.

For the obvious reason as enumerated above the Committee decided not to consider the financial bid of "Rajdeep Enterprises" for evaluation.

- The CEC considered remaining 6 Bids for financial evaluation. The unit rates for supplying manpower are fixed as per FIN-2 of Section 5 of RFP. The Committee observed that all the eligible bidders have quoted fixed price in FIN-2 for all components from A-1 to A-10 except A-7 i.e manpower for Office Messenger /Peon. The Committee deliberated over it and took congnisance of the following conditions of RFP
  - (i) That, the consolidated remuneration for office messenger/peon will be fixed as per the Finance Department Letter No 30722 dated 06.11.2021. (Narration in FIN-2)
  - (ii) Para 4 of the above Notification says "The employer contribution towards EPF and ESI for personnel provided through service provider will be reimbursed over and above the amount of consolidated remuneration of Rs.10100/-"

The conjoint reading of the above two points speaks that this part of remuneration is fixed i.e Rs.10100/ per manpower and subjected to change from time to time as may be notified by the Government. The payment of employer's contribution towards EPF/ESI is to be reimbursed by the Department.

Therefore the Committee unanimously decided to consider remuneration of office messenger/ peon mentioned at SI No A7 of "Summary of Financial Proposal" of RFP at fixed rate i.e. Rs 10,100/- per month and Rs 2,42,400/- (Rs10100\*2\*12) per annum equally for all Bidders for financial evaluation.

The financial bid scores were evaluated in consonance with the RFP and was normalized at fixed rate i.e. Rs 10,100/-per month and Rs 2,42,400/-(Rs10100\*2\*12) per annum

The detailed calculation sheet of normalized final scores (Technical & Financial) of 6 eligible bidders are placed at **Annexure-C** (Technical scores along with Financial scores) It was found that "Xeam Ventures Private Limited" has secured maximum score i.e. 100 out of 100(Technical and Financial scores combinedly) and emerged as successful bidder for award of contract as per clause no 7(iii) of RFP.

Hence the Committee unanimously recommended to consider bid of "Xeam Ventures Private Limited" for awarding the contract as per terms and conditions of e-tender.
