No.FE-DIV-FLD-0089-2021-(10F(Cons)-45/2021)- 21693 /FE&CC, In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Phulagandhi** under Chittrakonda Tahasil in the District of Malkangiri mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion of 13.233 ha of forest land for construction of Air Strip at Malkangiri by Executive Engineer, Malkangiri (R&B) Division, Malkangiri, Odisha, vide "Stage-I/in-principle" approval of Government of India, MoEF&CC, IRO, Bhubaneswar communicated in Letter No.5-ORC470/2021-BHU, dt.02.12.2021 under Section-2 of Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 13.350 ha (32.988 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Phulagandhi Protected Forest**".


