No.FE-FE2-CASE-0018-2020 13/FE&CC; Whereas Sri Ananta Prasad Badapanda, then Deputy Ranger filed an OA No. 650 (C)/2010 with a prayer "to direct the Respondents No. 1 & 2 i.e. FE&CC Department & O/o the PCCF & HoFF, Odisha respectively to give him promotion to the rank of Forest Ranger with all financial & consequential benefits from the date on which his the next junior joined as Forest Ranger, keeping in view the date of his retirement on 31/03/2010".

And whereas, the promotion case of Sri Badapanda, Deputy Ranger was not considered in the meeting of the DPC dated 18/02/2008 (O/o the PCCF, Odisha) due to pendency of 04 Disciplinary proceedings.

And whereas, the 04 Disciplinary proceedings initiated against Sri Badapanda were finalized vide Office Order No. 07 dated 06/02/2010 & Office Order No. 08 dated 06/02/2010 of DFO, Phulbani (KL) Division, Office Order No. 24 dated 05/02/2010 & Office Order No. 25 dated 05/02/2010 of DFO, Ghumsur (N) Division.

And whereas, the immediate junior of Sri Badapanda who got promoted to the rank of Forest Ranger on the basis of the recommendation of the DPC dated 18/02/2008 was Sri Golak Bihari Nanda.


And whereas, the OA No. 650 (C)/2010 was subsequently transferred to Hon'ble High Court and renumbered as WPC (OAC) No. 650/2010 and in its Order dated 15/07/2021 the OP No.1 i.e. FE&CC Department was directed to consider the representations filed by the petitioner vide Annexure-10 and 11 and pass appropriate order in accordance with law, taking into consideration Annexure-8. Meanwhile, the petitioner filed a CONTC No.7219/2021 wherein the Hon'ble High Court in its Order dated 10/12/2021 directed the OP No.1 i.e. FE&CC Department to comply with the Order dated 15/07/2021.

After careful consideration and thorough examination of the CCRs/PARs, pendency of DP/Vig. Cases, if any & other relevant documents, the Government have been pleased to promote Sri Ananta Prasad Badapanda, Deputy Ranger notionally to the rank of Forest Ranger, OFS, Group-B in the pre- revised Scale of Pay under ORSP Rules 2008 with usual D.A and other allowances as admissible from time to time w.e.f. 26/03/2008 i.e. the date his immediate junior Sri Golak Bihari Nanda got promoted to the rank of Forest Ranger.




Sri Ananta Prasad Badapanda will not be eligible for any arrear financial benefits for the period for which he has not actually worked in the higher grade post.






