No. **DAFE-OEII-MV-0003-2022** 1723 / FE, The auction of the Ambassador vehicle bearing Registration No. OR-02AK-2282 of the Department of Agriculture & Farmers' Empowerment published vide Auction Notice No. 24118 dt. 17.11.2022 has been cancelled due to insufficient eligible bidders. Hence, Sealed tender in plain papers/pad are once again invited by the undersigned for auction to the said Ambassador vehicle bearing Registration No. **OR-02AK-2282** in the upset price **Rs 18,000/-**.

The intending bidders may inspect the vehicles parked in the Secretariat premises of Krushi Bhawan, Gopabandhu Marg, Bhubaneswar in between 11.00 A.M. to 4.00 P.M. in any working days before submitting the tender. The tender should accompany earnest money deposit of Rs 2,000/- (Rupees two thousand) only in shape of Bank draft in favour of D.D.D.-cum-under-secretary to Government, Agriculture and Farmers' Empowerment Department payable at UCO Bank, Odisha Secretariat Branch, Bhubaneswar which will be refunded to the tenderers whose tenders are not accepted (except in case of the successful bidders).

The tender/bid should reach the undersigned **12.00 PM of 03.02.2023** at the latest and tenders received shall be opened before the Additional Secretary to Government, Agriculture and farmers Empowerment Department in charge of O.E.-II Section at **4.00 P.M. on 03.02.2023** in the presence of tenderers or their authorized representative. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.

The highest tender/bidder whose tender will be accepted shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.

The successful bidder shall take permission and remove the vehicle from Krushi Bhawan premises within 2 days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent @1% of the tender amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid site. If the ground rent so charged exceeds the sale price deposit then the tenderer shall cease to have any right on the vehicle & the amount deposited by him shall be adjusted towards ground rent.

The authority reserves the right to reject any or all tenders without assigning any reason thereof.
