No. FE-FE2-FE-0053-2022 198 /FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Deputy Rangers to the rank of Forest Rangers was held on 29.12.2021.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Sudarshan Dehury, Deputy Ranger was kept in "Sealed Cover" due to the pendency of 01 Vigilance case against him.

And whereas, the GA (Vigilance) Department in its Letter No. 22443 dated 25.12.2021 has stated that Cell File No. 21/90 is pending against Sri Dehury and the matter was referred to Regional Joint Director, SFP, Bhubaneswar vide L No. 731/Vig. Cell dated 13/04/1994 for initiation of Departmental proceeding and the same was initiated vide No. 1628 dated 03/09/1999 of DD, SFP, Puri Division. Result of the same is not available in this Department.

And whereas, the GA (Vigilance) Department was clarified regarding the misapprehension of the case vide this Department Letter No. 17775/FE&CC dated 30.09.2022 along with a request to accord the vigilance clearance in favour of Sri Dehury.

And whereas, the GA (Vigilance) Department in its Letter No. 25297 dated 04.11.2022 has intimated that "no case/enquiry is pending in Vigilance against Sri Sudarsan Dehury, Deputy Ranger, RO (I/C), Th. Rampur South Range, Kalahandi South Forest Division, Bhawanipatna".

And whereas, the Departmental Proceeding initiated against Sri Dehury vide Office Order No. 214 dated 21.10.1994 of Deputy Director, Social Forestry Project, Puri Division, Bhubaneswar arising out of the aforesaid Vigilance case has been finalized vide Office Order No. 176 dated 12.11.1999 of with the following punishments:

- · He is severely warned for future.
- One annual increment is stopped without cumulative effect.



And whereas, the Sealed Cover containing the findings of the Departmental Promotion Committee dated 29.12.2021 in respect of Sri Dehury, Deputy Ranger has been opened on 23.11.2022 and he is found suitable for promotion to the rank of Forest Ranger, OFS, Group-B.

And whereas, inter-se seniority of Sri Sudarshan Dehury will be above Sri Prasanna Kumar Sethy (Sl No. 104) and below Sri Antaryami Behera (Sl No.101) as per the Final Gradation List of Deputy Rangers published vide Office Order No. 1282 dated 28.12.2021 of PCCF & HoFF, Odisha.

Hence, after careful consideration the Government have been pleased to promote Sri Sudarshan Dehury, Deputy Ranger notionally to the rank of Forest Ranger, OFS, Group-B on ad-hoc basis for a period of one year or till receipt of the concurrence of OPSC or till his retirement, whichever is earlier in the Scale of Pay in Level 10 of Pay Matrix under ORSP Rules 2017 with usual D.A and other allowances as admissible from time to time w.e.f. 30.12.2021.

Sri Dehury will not be eligible for any arrear financial benefits for the period for which he has not actually worked in the higher grade post.

On promotion to the rank of Forest Ranger, Sri Dehury is posted to Daspalla Range under Nayagarh Division with immediate effect.
