No.FE-FE2-FE-0039-2022 <u>5868</u>/FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Deputy Rangers to the rank of Forest Rangers was held on 29.12.2021.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Ghasinath Patra, Deputy Ranger was kept in "Sealed Cover" due to the pendency of Disciplinary proceeding against him.

And whereas, the Departmental Proceeding initiated against Sri Patra vide Memorandum No. 167 dated 01.09.2021 of RCCF, Rourkela Circle has been finalized vide the OO No. 121 dated 06.06.2022 of RCCF, Rourkela Circle with the following punishments:

- · One annual increment is stopped without cumulative effect.
- · He is warned severely for future.

And whereas, upon finalization of the aforesaid Departmental Proceeding vide OO No. 121 dated 06.06.2022 of RCCF, Rourkela Circle, the Sealed Cover containing the findings of the Departmental Promotion Committee dated 29.12.2021 in respect of Sri Patra has been opened on 02.09.2022 and he is found suitable for promotion to the rank of Forest Ranger, OFS, Group-B in accordance to Para-3 of GA& PG Department OM No. 7844 dated 04.03.2020.

And whereas, as per the tentative gradation list of Deputy Rangers published by O/o the PCCF vide their OO No. 1282 dated 28.12.2021, the inter-se seniority of Sri Ghasinath Patra will be above Sri Maguni Behera (Sl No. 100) and below Sri Purna Chandra Swain (Sl No. 98) in the seniority list.

After careful consideration the Government have been pleased to promote Sri Ghasinath Patra, Deputy Ranger notionally to the rank of Forest Ranger, OFS, Group-B w.e.f 30.12.2021 on ad-hoc basis for a period of one year or till receipt of the concurrence of OPSC or till his retirement, whichever is earlier in the Scale of Pay in Level 10 of Pay Matrix under ORSP Rules 2017 with usual D.A and other allowances as admissible from time to time w.e.f. the actual date of joining in the promotional post of Forest Ranger.



Sri Patra will not be eligible for any arrear financial benefits for the period for which he has not actually worked in the higher grade post.

On promotion to the rank of Forest Ranger, Sri Ghasinath Patra is posted to Kendumundi range under Similipal North (WL) Division against existing vacancy with immediate effect.
