In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-**Gurundiamunda** under Pallahara Tahasil in the District of Angul mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion of 2107 ha. of forest land for construction of Rengali Irrigation Project (Barrage and Canal Systems) in Angul, Cuttack, Dhenkanal and Keonjhar Districts of Odisha therein vide 'in-principle' approval of Government of India, MoEF&CC (FC Division), New Delhi communicated in letter No.8-53/96-FC, dt.21.11.1996 under section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 4.512 ha (11.15 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Gurundiamunda Protected Forest**".
