The engaged Officers shall be governed under Odisha Government Servants' Conduct Rules, 1959 and are liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Civil Services (Pension) Rules, 1992. All Acts, rules and regulations applicable to a Government employee shall be applicable to them, mutatis mutandis.
- 6. The engagement can be terminated at any time by the competent authority due to unsatisfactory performance by giving one month's notice. On the contrary, if any OSD desires to resign, he/she shall do so by giving one month's written notice to the competent authority.
- 7. Preference will be given to the retired Officers, those have been retired from Government service within a period of two years.
