After careful consideration of the demands of Odisha Non-Gazetted Forest Service Association regarding enhancement of various allowances, Government have been pleased to revise allowances as follows:

(a) Special Diet Allowance is enhanced from Rs.350/- to Rs.750/- per month in favour of all Forest Guards.


(b) Motor Cycle Allowance is enhanced from Rs.350/- to Rs.550/- per month in favour of Forester, Deputy Ranger, Forest Ranger having their Motor Cycle.

This rate of enhancement of Special Diet Allowance and Motor Cycle Allowance shall come into effect from the date of issue of the Resolution.




