No. FE-FE2-DP-0096-2017 <u>15333</u> /FE&CC; Whereas Sri Kalakar Mohanty, Forest Ranger (Retd.) was dismissed from the Government service vide this Department Office Order No. 11043/F&E dated 18.06.2010 in accordance to the judgment dated 17.01.2009 of Hon'ble Special Judge Vigilance, Jeypore.

And whereas, Sri Mohanty preferred an appeal before the Hon'ble High Court vide CRLA No. 54 of 2009 against the judgment dated 17.01.2009 of Hon'ble Special Judge Vigilance, Jeypore.

And whereas, the Hon'ble High Court vide their Order dated 10.10.2017 passed in CRLA No. 54 of 2009 set aside the conviction & the sentences passed by the Hon'ble Special Judge Vigilance, Jeypore & acquitted him from all the charges.

And whereas, the GA Vigilance Department has decided not to prefer an appeal in the higher forum against the judgment dated 10.10.2017 of the Hon'ble High Court passed in CRLA No. 54 of 2009 filed by Sri Mohanty.

And whereas, the Government decided to implement the Hon'ble High Court's Order dated 10.10.2017 & as such revoked the dismissal order vide this Department Order No. 17287/F&E dated 06.08.2018.

And whereas, upon acquittal of Sri Mohanty in Berhampur Vigilance PS Case No. 22/89 u/s-5(2) rw 5(i) (c) PC Act 1947 / 467 /471/ 477-A/34/IPC/ and charges framed against him for trial vide GR Case No. 28 of 1989 / TR No. 113 of 2007 & subsequent revocation of the dismissal order issued vide this Department Office Order No. 11043/F&E dated 18.06.2010, the Government is pleased to promote (Notionally) Sri Kalakar Mohanty to the post of Assistant Conservator of Forests, OFS (JB) w.e.f 11.07.2012 i.e. the date his immediate junior namely Sayed Haniff (SI No. 88 in the tentative seniority list of Forest Rangers as on 01/11/2009) got promoted to the post of Assi. Conservator of Forests.
