No. FE-FE2-CASE-0046-2023 16441 /FE&CC; Whereas in compliance to the Order No. 1 dated 03.09.2021 passed by the Hon'ble High Court in W.P (C) No. 26206 of 2021, Sri Durga Madhab Padhi, Deputy Ranger (Retd.) was notionally promoted from the rank of Forester to Deputy Ranger w.e.f 29.05.2014 i.e. the date his immediate junior Sri Arjun Mohan Pradhan was promoted to the rank of Deputy Ranger vide Office Order No. 1239 dated 14.12.2021 of PCCF & HoFF, Odisha.

And whereas, the Hon'ble High Court vide their Order No. 1 dated 03.09.2021 passed in W.P (C) No. 26206 of 2021 has directed as follows:

"xxxxx It is keeping in this view, this Court in disposal of the writ petition directs the Secretary, Forest and Environment, Department-opposite party no.1 and Principal Chief Conservator of Forests-O.P. No.2 to give promotions to the petitioner to the rank of Dy. Ranger and Forest Ranger from the date of his juniors and batchmates got such promotions. However, the promotions of the petitioner as per direction of this Court shall be subject to the ultimate outcome in the departmental proceeding xxxxx".

And whereas, in obedience to the aforesaid Order, the status of Departmental Proceeding/Vigilance case, if any pending against Sri Padhi, CCRs for the preceding 05 years from 31.03.2016 i.e. the date his immediate junior i.e. Sri Arjun Mohan Pradhan was promoted to the rank of Forest Ranger was obtained from the O/o the PCCF & HoFF, Odisha.

And whereas it has been ascertained by O/o the PCCF & HoFF, Odisha that No Departmental Proceeding/Vigilance case is pending against Sri Padhi, no adverse remarks in the CCRs of Sri Padhi for 05 preceding years from 31.03.2016 were communicated.

And whereas, the CCRs of Sri Padhi for the period 2015-16, 2014-15, 2013-14, 2012-13, 2011-12 as well as back period i.e. beyond the preceding 05 years as received from O/o the PCCF & HoFF, Odisha was examined and found to be appropriate.

Hence, after careful consideration the Government have been pleased to notionally promote Sri Durga Madhab Padhi, Deputy Ranger (Retd.) to the rank of Forest Ranger, OFS (Group-B) w.e.f. 31.03.2016 i.e. the date his immediate junior Sri Arjun Mohan got promoted to the rank of Forest Ranger, OFS (Group-B).



Sri Padhi will be eligible for arrear financial benefits from 31.03.2016 till the date of his retirement from Government Service on attaining the age of superannuation.




