No. FE-FE2-FE-0032-2023 <u>17190</u>/FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Forest Rangers to the post of Assistant Conservator of Forests was held on 24.02.2023.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Nilamani Dehury, Forest Ranger was kept in "Sealed Cover" due to the pendency of 01 Disciplinary proceeding initiated against him.

And whereas, the Departmental Proceeding initiated against Sri Dehury vide this Department Memorandum No. 6203/FE&CC dated 30.03.2022 has been finalized vide this Department Office Order No. 14363/FE&CC dated 10.07.2023 with the following punishment:

• 1.The DO may be censured in future.

And whereas, upon finalization of the aforesaid Departmental Proceeding, the Sealed Cover containing the findings of the Departmental Promotion Committee dated 24.02.2023 in respect of Sri Dehury has been opened on 09.08.2023 by Additional Secretary to Government.

And whereas, the punishment awarded to Sri Dehury vide this Department Office Order No. 14363/FE&CC dated 10.07.2023 is minor in nature.

And whereas, Sri Dehury is eligible for getting promotion (notionally) to the post of Assistant Conservator of Forests from the date his immediate junior got promotion to the said rank in accordance to Para-3 of GA& PG Department OM No. 7844 dated 04.03.2020.

Hence, the Government after careful consideration have been pleased to promote Sri Nilamani Dehury, Forest Ranger to the post of Assistant Conservator of Forests, OFS (JB), Group-A on ad-hoc basis for a period of one year or till receipt of the recommendation of OPSC or till their retirement, whichever is earlier in the scale of pay in Pay Matrix Level-12 of ORSP Rules, 2017 with usual DA & other allowances as admissible from time to time w.e.f 06.03.2023 i.e. the date his immediate junior Sri Sachidananda Sethi got promotion to the post of Assistant Conservator of Forests.



The inter-se seniority of Sri Nilamani Dehury will be fixed above Sri Sachidananda Sethi (Sl No. 136) and below Manikeswari Hansdah (Sl No. 135) as per the Final gradation list of Forest Rangers published vide this Department Letter No. 20730/FE&CC dated 22.11.2022.

Sri Nilamani Dehury will be eligible for arrear financial benefits for the period from 06.03.2023 to the date of publication of this Notification in the higher grade post.

On promotion to the post of Assistant Conservator of Forests, OFS (JB), Group-A, Sri Nilamani Dehury is posted as ACF, (I/c) Kaniha Range under Angul Forest Division with immediate effect.
