No. FE-FE2-FE-0011-2020 22758/FE&CC; Whereas the promotion of Sri Samarendra Thakur, Forest Ranger, Lephripara (KL) Range, Rourkela (KL) Division to the rank of Assistant Conservator of Forests, OFS (JB) was not considered in the Departmental Promotion Committee meeting held on 24.02.2023 & 28.03.2023 due to non-passing of Departmental examination (Sub:Forest Law & Rules (Written)).

And whereas, Sri Thakur passed Forest Law & Rules (Written) subject vide Notification No. 140 dated 10.03.2023 of Board of Revenue, Odisha.

And whereas, Sri Thakur appeared before the Additional Chief Secretary on 16.10.2023 with a prayer for consideration of his promotion to the rank of Assistant Conservator of Forests, OFS (JB) since he is on the verge of retirement.

And whereas, a Departmental Promotion Committee meeting was scheduled to be held on 31.10.2023 for consideration of promotion of Sri Thakur to the rank of Assistant Conservator of Forests.

And whereas, the PARs for the period 2022-23, 2021-22, 2020-21, 2019-20, 2018-19 & back period was obtained from the Confidential Section, FE&CC Department which was found to be appropriate/adequate.

And whereas, the GA (Vigilance) Department vide their Letter No. 21245 dated 31.10.2023 intimated that no case/enquiry is pending in Vigilance against Sri Samarendra Thakur, Forest Ranger, Lephripara (KL) Range, Rourkela (KL) Division. As per the available records in this Department, no Departmental Proceeding is pending against Sri Thakur.

Hence, the Government after careful consideration decide to promote Sri Samarendra Thakur, Forest Ranger, OFS (Group-B) to the rank of Assistant Conservator of Forests, OFS (JB), Group-A on ad-hoc basis for a period of one year or till receipt of the recommendation of OPSC or till their retirement, whichever is earlier in the scale of Pay in Pay Matrix Level-12 of ORSP Rules, 2017 with usual DA & other allowances as admissible from time to time with effect from 31.10.2023 as per the recommendation of Departmental Promotion Committee meeting held on 31.10.2023.

Upon promotion to the rank of Assistant Conservator of Forests, Sri Samarendra Thakur is hereby posted as SDFO, Sundargarh (KL) Sub-Division with immediate effect.
