- 1. Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records, physically fit and sound basic computer knowledge (MS Office, e-mail and OSWAS etc.) are eligible for engagement.
- 2. Officers against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding five years of retirement are not eligible for consideration.
- 3. The engagement will be made as per terms and conditions as laid down vide GA Department Resolution No. 23750/ Gen, Dt. 27.08.2014.
- 4. The consolidated remuneration of the OSDs shall be fixed as per Finance Department O.M. No. 24533/F Dt. 29.09.2022.
- 5. The engaged Officers shall be governed under Odisha Government Servants' Conduct Rules, 1959 and are liable to be proceeded against their misconduct, omissions and commissions as per the provisions under the Odisha Civil Services (Pension) Rules, 1992. All Acts, rules and regulations applicable to a Government employee shall be applicable to them, mutatis mutandis.
- 6. The engagement can be terminated at any time by the competent authority due to unsatisfactory performance by giving one month's notice. On the contrary, if any OSD desires to resign, he/she shall do so by giving one month's written notice to the competent authority.
