No. FE-FE2-FE-0037-2021 <u>25279</u> /FE&CC, In pursuance of Rule- 15 (4) of Odisha Forest Service, Group 'B' (Recruitment and Conditions of Service) Rules, 2013 and after successful completion of Induction Training Course of Forest Range Officer Trainees 2022-23 Batch from Odisha Forest Ranger's College, Angul, the State Government do hereby appoint the following 28 (twenty-eight) Forest Range Officer Trainees as Forest Range Officer, Odisha Forest Service, Group-B in the scale of pay of Rs. 44,900/- in Pay Matrix-10, Cell-01 of Odisha Revised Scale of Pay Rules, 2017 under Forest, Environment & Climate Change Department with usual Dearness Allowance and other Allowances as may be sanctioned by the Government of Odisha from time to time.

Their appointment shall be on probation for a period of 02 (two) years provided that such period of probation shall not include Extra Ordinary leave, period of unauthorized absence or any other period held to be not being on actual duty.

Further, the appointment of probationer may for good and sufficient reasons can be terminated by Government at any time without previous notice during the period of probation including extension of such period, if any under Clause (1) and (2) of Rule 21 of Odisha Forest Service, Group 'B' (Recruitment and Conditions of Service) Rules, 2013.

On being appointed, the following Forest Range Officers (Probationers) are posted in the Forest Ranges shall undergo 2 months of Training on Official Procedures at the respective Divisions and will posted in the Ranges as mentioned against their names:
