OFFICE ORDER

No.PT2-FE-FE2-FE-0011-2020 1280 /FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Forest Rangers, OFS (Group-B) to the rank of Assistant Conservator of Forests, OFS (JB) was held on 24.02.2023.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Pradeep Kumar Behera, Forest Ranger kept in "Sealed Cover" due to the pendency of 01 Disciplinary proceeding initiated vide this Department Memorandum No. 22683/FE&CC dated 20.12.2022.

And whereas, the aforesaid Departmental Proceeding initiated against Sri Behera has been finalized vide this Department Office Order No. 286/FE&CC dated 04.01.2024 with the following penalties:

- One annual increment of the delinquent may be stopped without cumulative effect.
- His suspension period may be treated as Leave due.
- He may be censured.

And whereas, in pursuance to Para-2 (6) of GA Department Office Memorandum No. 29699 dtd. 01.11.1997, the Sealed Cover in respect of Sri Behera has been opened by the Additional Secretary to Government on 08.01.2024.

And whereas, in accordance to Para-6 of GA Department Department Office Memorandum No. 3928 dated 18.02.1994 r/w Para-2 (6.3) of GA Department Department Office Memorandum No. 29699 dated 01.11.2017, Sri Behera is eligible to get promotion to the rank of Assistant Conservator of Forests w.e.f 06.03.2023 i.e. the date his immediate junior Himani Nayak got promoted to the rank of Assistant Conservator of Forests, OFS (JB).

Hence, after careful consideration, the Government have been pleased to notionally promote Sri Pradeep Kumar Behera to the rank of Assistant Conservator of Forests, OFS (JB) with usual D.A and other allowances as admissible from time to time w.e.f. 06.03.2023 i.e. the date his immediate junior Himani Nayak (as per Final Gradation List of Forest Rangers as on 01.09.2022, circulated vide this Department Letter No. 20730/FE&CC dtd. 22.11.2022) got promoted to the rank of Assistant Conservator of Forests, OFS (JB).




The inter-se-seniority of Sri Pradeep Kumar Behera is hereby fixed above Himani Nayak (SI No. 186) & below Sonali Sio (SI No. 185) in the Tentative Gradation List of Assistant Conservator of Forests, OFS (JB) as on 01.10.2023.

Upon promotion to the rank of Assistant Conservator of Forests, OFS (JB), Sri Pradeep Kumar Behera is hereby posted as ACF (Affn, FF & Communication), Ghumsur South Division against the existing vacancy with immediate effect.


Sri Pradeep Kumar Behera will not be eligible for arrear financial benefits.




