No. FE-FE2-FE-0006-2024 – 3295/FE&CC., Whereas, a meeting of the Departmental Promotion Committee for the promotion of Forest Rangers to the rank of Assistant Conservator of Forests was held on 24.02.2023.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Gajendra Pal Singh Mathur, Forest Ranger was kept in "Sealed Cover" due to the pendency of 01 Departmental Proceeding initiated vide this Department Memorandum No. 17408/FE&CC, dated 28.09.2022.


And whereas, the Departmental Proceeding initiated vide this Department Memorandum No. 17408/FE&CC, dated 28.09.2022 has been finalized vide this Department Office Order No. 2150/FE&CC, dated 06.02.2024 with the following penalties:

1. 50% of the loss of Government money i.e. Rs. 1,14,270/- may be recovered from the delinquent Forest Ranger
2. One increment of the delinquent Forest Ranger may be stopped Without cumulative effect,
3. The period of suspension of the delinquent may treated as leave due,
4. He may be censured,

And whereas, the penalties awarded to Sri Mathur is minor in nature & in accordance with Para-2 (6.3) of GA Department Office Memorandum No. 29699 dated 01.11.1997, the Sealed Cover containing the findings of the Departmental Promotion Committee in respect of Sri Mathur was opened by the Additional Secretary to Govt. on 22.02.2024.

And whereas, in accordance to Para-2 (6.3) of GA Department Office Memorandum No. 29699 dated 01.11.1997, Sri Mathur, Forest Ranger is found suitable for promotion to the rank of Assistant Conservator of Forests, OFS (JB) w.e.f the date his immediate junior has got promotion to the rank of Assistant Conservator of Forests, OFS (JB).

Hence, after careful consideration, the Government have been pleased to notionally promote Sri Gajendra Pal Singh Mathur, Forest Ranger, Nuapada Wildlife Range, Sunabeda (WL) Division to the rank of Assistant Conservator of Forests, OFS (JB) w.e.f. 06.03.2023 i.e. the date his immediate junior Sri Promod Ku Sethy got promoted to the rank of Assistant Conservator of Forests, OFS (JB).


The inter-se-seniority of Sri Gajendra Pal Singh Mathur is hereby fixed below Sri Sumit Mohanty at Sl. No. 128 & above Sri Promod Ku Sethy at Sl. No. 129 in the Tentative Gradation List of Assistant Conservator of Forests, OFS (JB) as on 01.10.2023.


Sri Mathur will not be eligible for any arrear financial benefits from 06.03.2023.




