No. FE-FE2-FE-0007-2024 – 4278 /FE&CC., Whereas a meeting of the Departmental Promotion Committee for the promotion of Deputy Rangers to the rank of Forest Rangers was held on 28.12.2023.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Keshaba Kishor Naik, Deputy Ranger was kept in "Sealed Cover" due to the pendency of 01 Departmental Proceeding initiated vide this Department Memorandum No. 110, Dated. 19.08.2022 of RCCF, Bhawanipatna Circle, Bhawanipatna.

And whereas, the Departmental Proceeding initiated vide this Department Memorandum No. 110, Dated. 19.08.2022 of RCCF, Bhawanipatna Circle, Bhawanipatna. has been finalized vide office order No. 49, Dated. 06.02.2024 of the RCCF, Bhawanipatna Circle with the following penalties:

1. One increment is stopped without cumulative effect.
2. He is censured.

The inter-se-seniority of Sri Keshaba Kishor Naik will be fixed below Sri Sibaram Nayak at Sl. No. 12 & above Sri Satyananda Pal at Sl. No. 29 in the Gradation List of Forest Rangers, as on 05.01.2024.








