No.FE-FE2-CASE-0034-2021 15864 /FE&CC; Whereas a meeting of the Departmental Promotion Committee for promotion of Forest Rangers, OFS (Group-B) to the rank of Assistant Conservator of Forests, OFS (JB) was held on 16.05.2017.

And whereas, the findings of the Departmental Promotion Committee in respect of Sri Nalinikanta Behera, Forest Ranger was kept in "Sealed Cover" due to the pendency of SBP (V) PS Case No. 11 dated. 18.02.2003.

And whereas, Sri Nalinikanta Behera was acquitted from SBP (V) PS Case No. 11 dated. 18.02.2003 vide Judgment dated. 19.02.2024 of the Special Judge, Vigilance, Sambalpur.

And whereas, the GA (Vigilance) Department has decided not to prefer appeal before the Hon'ble High Court against the acquittal judgement.

And whereas, in pursuance of Para-2 of GA Department Office Memorandum No. 29699 dtd. 01.11.1997, the Sealed Cover in respect of Sri Nalinikanta Behera has been opened by the Additional Secretary to Government on 31.07.2024.

And whereas, in accordance to Para-6 of GA Department Department Office Memorandum No. 3928 dated 18.02.1994 r/w Para-2 of GA Department Department Office Memorandum No. 29699 dated 01.11.2017, Sri Nalinikanta Behera is eligible for promotion to the post of Assistant Conservator of Forests w.e.f 01.02.2018 i.e. the date his immediate junior got promoted to the rank of Assistant Conservator of Forests, OFS (JB) in the DPC Meeting dated 16.05.2017.


Hence, the Government after careful consideration have been pleased to promote (notional) Sri Nalinikanta Behera to the post of Assistant Conservator of Forests, OFS (JB) with usual D.A and other allowances as admissible from time to time w.e.f. 01.02.2018 i.e. the date his immediate junior in the Tentative Gradation List of Forest Rangers, OFS, Group-B published vide this Department Letter No.5435 dated 17.03.2017 got promoted to the post of Assistant Conservator of Forests, OFS (JB) as per recommendation of the Departmental Promotion Committee meeting held on 16.05.2017.

The inter-se-seniority of Sri Nalinikanta Behera is hereby fixed above SI No. 17 in the Tentative Gradation List of Assistant Conservator of Forests, OFS (JB) as on 01.10.2023 circulated vide this Department Letter No. 22209/FE&CC dated. 20.10.2023.

Upon promotion to the post of Assistant Conservator of Forests, OFS (JB), Sri Nalinikanta Behera is hereby posted at O/o the RCCF, Koraput Circle, Koraput against the existing vacancy with immediate effect.


Sri Nalinikanta Behera will be eligible for arrear financial benefits from 01.02.2018 till prior to his date of joining in the post of Assistant Conservator of Forests, OFS (JB).


