No.FE-DIV-FLD-0101-2021-{10F-(Cons)-179/2015}- **15653** /FE&CC, In exercise of the powers conferred under Section-33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Champajhar** under Banspal Tahasil of Keonjhar District mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against the proposed diversion of 79.367 ha of forest land in favour of Shri Avin Jain (Heir of Late Shri DC Jain) for mining of Iron and Manganese Ore in Dalpahar Iron & Manganese Ore Mines located in Baitarani RF II, District Keonjhar (Odisha) vide in-principle approval of Government of India, MoEF&CC (FC Division), New Delhi communicated in letter File No.8-31/2015FC (E-91138), dtd.13.02.2026 under Section-2 (1) (ii) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, the limits of which are specified below and the area of which is 9.800 Ha or 24.2159 Ac shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**Champajhar Protected Forest**".
